- AS OF 01/01/2015 ALL DRIVERS COMPETING IN CAMS STATE LEVEL & ABOVE RACING EVENTS MUST WEAR AN APPROVED FRONTAL HEAD RESTRAINT DURING ALL ACTIVITIES.  
(excludes some Historic 5th category classes: refer 2018 CAMS manual for exemptions list).
- AS OF 01/01/2015 ALL VEHICLES COMPETING IN CAMS STATE LEVELS & ABOVE RACING EVENTS MUST BE FITTED WITH AN APPROVED FIVE (5) POINT OR SIX (6) POINT (TYPE A) SAFETY HARNESS.
